Pastor Toensing indicated he would connect with one of our members to better gauge and process the request. The Committee is open to help this presentation forward with the knowledge it currently has. No formal action taken.
- e. Church Website – Tim shared recent statistics on site visits to our Church website through May. No action taken.
- f. Welcome Folders – Tim obtained a trial mount for the 'Welcome Folders' to be used as a folder rack connected to the guest registry stand for easier access to the Welcome Folders. Mounting will commence as opportunity and visualization transpires. No formal action taken.
- g. Updated Membership Contact List – An update was provided that the church office is continuing the work in developing an updated phone/address directory. There are needed adjustments to be made to the updated Servant Keeper software that will require additional time. No action taken.

Tim will proceed to invite both the Council and the Voters during their next meetings in hopes of collecting an initial 12 participants to take part in this training.
